4. *The proposed is aware of Rotary's community service responsibilities and will make every effort to participate in them; individual financial obligations of membership to the club include annual dues and weekly meeting costs (See below).*
5. *Annual contributions to the Tigard Breakfast Rotary Foundation and the Rotary International Foundation of "Every Rotarian, Every Year" in a suggested minimum donation amount of \$100.00.*
